**PRINCE STREET GALLERY** represents contemporary figurative and abstract artists. The gallery, now in its 38<sup>th</sup> year, first opened its doors on Prince Street in SoHo in 1970. Prince Street Gallery originally emerged out of the Alliance of Figurative Artists. During its founding years the gallery received encouragement from The New York State Council on the Arts in the form of grants supporting exhibitions and a catalogue. In 1980, the gallery moved to Wooster Street where it remained until 2001 when it reopened at 530 West 25<sup>th</sup> Street in Chelsea. Last year Prince Street Gallery hosted its First National Juried Exhibition and guest lecture with juror, Philip Pearlstein, and is now hosting its Second National Juried Exhibition and guest lecture with juror, **IRVING SANDLER**.

Distinguished juror **IRVING SANDLER**, critic, art historian, and author, is a dynamic and influential presence in the American art world. His books include, *Triumph of American Painting: A History of Abstract Expressionism* (1970) and *A Sweeper-Up After Artists: A Memoir* (1993). Irving Sandler's most recent book, *Avant Garde to Pluralism: An-On-The-Spot History* (2006), is his most comprehensive book to date.

### ELIGIBILITY:

All artists who currently reside within the USA are eligible to apply. Artists and associates currently affiliated with Prince Street Gallery are not eligible. Paintings, drawings, and prints may be submitted. No photographs, please.

### REQUIREMENTS:

Size of work, including frame, must not exceed 26" in any direction. For works on paper, plexiglass must be used in lieu of glass unless hand delivered and personally picked up from the gallery.

### FEES:

The entry fee of \$30 will cover 3 images. A \$5 fee will cover each additional image, for a maximum of 6 images. Kindly make checks payable to "Prince Street Gallery".

### SUBMISSIONS:

Please submit **digital images** of your work. All entries must be saved to a CD as JPEG images. (Please make sure that the JPEG quality is set to at least 80%). Complete both parts of the Entry Form entirely and submit it along with the CD.

Please label each CD with **Your Name** and **label/title each JPEG image** with:

Last Name, First Name **and** Entry Letter that corresponds with image

(**A, B, C, D, E** or **F**) on Entry Form/Notification Card, *for example:*

\*Please note that we are **not** accepting e-mailed entries, slides or print-outs of images.

### ACCEPTED WORK:

All work must be received no later than Saturday, December 15, 2007, between 11 and 6 PM. Late

arriving work cannot be hung. Selected work that is shipped must arrive in a reusable container. A pre-paid method for return must be enclosed, and the work ready for hanging. Please make pre-paid shipping arrangements through UPS or FEDEX as COD returns are not accepted.

### SALES:

All works are for sale unless otherwise stated. Prince Street Gallery takes no commission on sales from this exhibition.

### LIABILITY:

All possible care will be taken to guarantee safety of work. Prince Street Gallery's insurance will cover work **ONLY** while it is hanging in the gallery. The gallery will not bear liability for any loss or damage while in transit. Transit insurance is the responsibility of the artist.

### REMOVAL OF WORK:

Work not picked up on time will be stored at a fee of \$7.50 per day.
